MEMORANDUM FOR RECORD

Subject: Summary and Recommended Disposition of Use of Government IT Equipment and Associated Files and Documents from that Same Equipment by [REDACTED]

1. Purpose. The purpose of this Memorandum for Record is to document the use of government information technology (IT) equipment assigned to [REDACTED] organization by [REDACTED] during the period of March to May 2008 along with the associated files and documents from that same IT equipment. From this work I was asked to determine if any administrative personnel actions should occur to [REDACTED] or anyone else. The informal investigation that I conducted to derive my findings and recommendations was made from several source documents cited below and discussions with various key persons. These include: statements and emails from individuals assigned to the Automation Services Division (ASD) of the Support Directorate; emails from [REDACTED] (b)(6) that directed this review; informal discussions (no formal prepared questions) with [REDACTED] (b)(6), a contractor that is assigned to ASD; informal discussions (no formal prepared questions) with [REDACTED] (b)(6) at our serving CPAC; informal discussions (no formal prepared questions) with [REDACTED] (b)(6) of the Fort Eustis DOIM, and finally informal discussions (no formal prepared questions) with Ms Sheila Ahrens.

2. Background.

a. In early Summer 2007 and because of ongoing construction within the HPIC building that [REDACTED] would normally occupy coupled with the outcome of an Investigation of Property Loss (IOPL) by [REDACTED] (b)(6) of ATSC against a member of her organization headquartered at Fort Lee, Virginia who was further assigned and rated by [REDACTED] (b)(6) (VTT team chief), she decided to move her workplace to Building 1514. This was done after approximately a year being assigned as the division chief position where under the guidance/direction from her then supervisor [REDACTED] (b)(6) [REDACTED] (b)(6)) that she spend the preponderance of her time with the newly reengineered staff and faculty (HPIC) effort and not the VTT program.

b. Once she arrived and began to better determine the needed followon work at Fort Lee beyond the IOPL and associated improvements to property accountability and other changes within that same VTT organization, she learned much more about underlying and possibly systemic issues and concerns at Fort Lee and within Building 1514 workplace itself. In the Fall of 2007, she was detailed to a set of duties to allow her to

focus on many of these areas while also determining that an independent AR 15-6 investigation from HQ, TRADOC was also required to properly investigate and direct/dispose of various property/equipment at Fort Lee and elsewhere. During this same timeframe (January 2008), (b)(6) was conducting an informal investigation which was initiated from an employee alleging misconduct among members of Bldg 1514 over a period of several years. As documented by (b)(6) through statements she gathered as a part of this investigation, Ms. Ahren's presence in the workplace (Bldg 1514) was certainly not welcomed for various reasons by a majority of the assigned workers and, moreover, they alleged that she created the hostile work environment.

c. While the detail for (b)(6) was in place, it was rarely enforced. For example, (b)(6) took various leaves during this same time period and in all cases, (b)(6) was never allowed to review or approve those requests. Yet, they were approved in some cases by (b)(6) whom (b)(6) continued to rate. On the 5th of February 2008, (b)(6) was encouraged and agreed to be reassigned to (b)(6) division without the knowledge, understanding and approval of (b)(6). Meanwhile, (b)(6) was working various VTT/SEN actions that would normally have required both (b)(6) both of whom were either on leave or retiring from civil service and (b)(6) who had already displaced. This left (b)(6) in an extremis situation and (b)(6) even though she was tasked to conduct a handoff of much of her ongoing work/key actions, it was never properly accomplished with (b)(6). Consequently, these particular VTT/SEN files eventually found on (b)(6) computer were the same ones asked for by the AR 15-6 investigating officer, (b)(6) and needed all along by (b)(6) but because of this poor transition and the files not being properly transferred, it clearly hampered his 15-6 work and others.

### 3. Chronological sequence of events-

a. On 30 April 2008 and as part of life cycle replacement/transitioning of (b)(6) computer, (b)(6) asked (b)(6) if there was anything on (b)(6) computer that she needed. (b)(6) asked him to provide backup of certain files but because of the difficulty/time required of that effort he chose to provide (b)(6) the hard drive itself.

b. On 14 May 2008 and to assist (b)(6) in finding many of the needed files he was looking for to close out the investigation, (b)(6) took the hard drive home and plugged it into (a USB connection) her government laptop which she takes home on numerous occasions to complete work, etc. During the scan of the hard drive for these VTT/SEN files by Ms. Ahrens she discovered various inappropriate emails and JPEG

files, etc. covering some three years which she printed some off and provided to me on 19 May 2008. She never hooked the hard drive into a personal PC or any other government computer besides her own laptop.

c. On 19 May 2008, [REDACTED] provided me a detailed packet of information which she stated she pulled off of this same hard drive and subsequently printed. It was only a portion of what she discovered on the hard drive and included inappropriate emails from various sources; pornography; inappropriate jokes and other information that potentially provided information related to inappropriate behavior in the ATSC work place (Bldg 1514). She asked that it be reviewed by leadership with follow-up discussions to determine how to best proceed.

d. On 22 May 2008, [REDACTED] directed with the advice of the local SJA that [REDACTED] laptop, [REDACTED] computer (that [REDACTED] as secured separately), [REDACTED] hard drive, and the current computer assigned to her at her new workplace be confiscated by ASD personnel. [REDACTED] had secured [REDACTED] hard drive at home and they went to her home to retrieve/secure that same hard drive.

e. On 27 May 2008, [REDACTED] and [REDACTED] met with [REDACTED] for what I thought was to determine the contents and disposition of the printed documents that [REDACTED] brought forward on 19 May 2008 to me. I was not present for this. What I thought- June/July 2008- I received numerous attachments/emails from ASD as to what was found on the respective hard drives which included all that was acknowledged by [REDACTED] previously (see enclosures). No child pornography was ever found and consequently CID was never a part of this investigation.

f. On 30 June 2008, [REDACTED] laptop was returned to her. The disposition of both [REDACTED] hard drive and [REDACTED] computer/CPU is not known.

4. Summary. Given the hostile work environment within 1514 as determined by the statements [REDACTED] took during her complimentary investigation over the many months after [REDACTED] moved into that building, the reasons for [REDACTED] viewing the information she did on the [REDACTED] hard drive are clear. She needed that information that was not forthcoming from [REDACTED] and when given the opportunity to do so she did. While AR 25-2 prohibits Army personnel from browsing and accessing other user email accounts, in this case the work by [REDACTED] was fully justified. The peripheral information that she also found but wasn't initially looking for (e.g. inappropriate jokes, pornography, and emails, etc.) was what she printed and forwarded to me on 19 May 2008 and must be properly investigated as well.

5. Recommendations. As outlined in the summary, nothing further should be done against the IT related actions that [REDACTED] took to derive the files needed to finish the AR 15-6 investigation. As discussed, these were never forthcoming from [REDACTED] [REDACTED] during her transition out of that organization and [REDACTED] felt it was proper for her to find additional and needed information. The various inappropriate files, etc. were printed and given to me, which I have still secured. While printing of this material may not normally be appropriate, in this case and given the circumstances it was required to prepare a logical packet of chronological information that [REDACTED] prepared and provided to me on 19 May 08. There were no violations of AR 25-2 according to [REDACTED] the Fort Eustis DOIM. As CID stated previously, while they would not investigate this they recommended the information be destroyed but only after all administrative actions and follow-up be completed. This has not occurred and the specific hard drives mentioned above with a series of questions to be developed coupled with the incomplete investigation started but not finished by [REDACTED] should be the basis for a further investigation. The purpose should be to determine the appropriate disposition of these various inappropriate files, etc. along with other indicators or various inappropriate behavior, etc. in the VTT/SEN workplace by potentially a large number of government, military, and contract personnel.

(b)(6) did find some "questionable, inappropriate" "dirty jokes" (the kind that should not be passed around by a government employee) however, probably would not be deemed true pornography - but would be offensive to most folks (i.e. myself - I saw a couple of them from (b)(6) - and it is not acceptable material nor would I want to receive them)
3. Machine number 3 - (b)(6) is currently being scanned (b)(6) has gotten kicked off it a couple of times and restarted the scan).
4. Machine number 4 - The original machine from (b)(6) old machine is getting the hard drive reinstalled so that it can be scanned.

Machine number 1 - [REDACTED]

I found nothing on this machine indicative of pornography or adult themed material. Going through .pst files, with particular attention to the Sent Items folder, I did not find anything questionable or to suggest that [REDACTED] asked anyone external to ATSC for help regarding

Machine number 2 - [REDACTED] (b)(6) (current PC)

I and [REDACTED] (b)(6) both reviewed this machine and found some questionable, inappropriate or adult themed jokes within [REDACTED] (b)(6) .pst file. These "jokes" should not be received or passed around by a government employee on a government system, however; none of the "jokes" were sent to [REDACTED] (b)(6) was frequent recipient of these "jokes" by [REDACTED] (b)(6)

Machine number 3 - [REDACTED] (b)(6)

I reviewed this machine and found some questionable, inappropriate or adult themed jokes within [REDACTED] (b)(6) .pst file. These "jokes" should not be received or passed around by a government employee on a government system, however; none of the "jokes" were sent to [REDACTED] (b)(6) generally forwarded these "jokes" to .com addresses.

Machine number 4 - [REDACTED] (b)(6) (old PC)

I followed [REDACTED] (b)(6) to her house to pick up the hard drive for this machine. When the NE [REDACTED] (b)(6) and I were connecting the drive into the old PC, we noticed that the slide mounting brackets were facing the wrong way. This would imply that the brackets had been removed, possibly to put the hard drive into another computer, and reattached the wrong way. After reviewing this machine I found nothing inconsistent with what was found on [REDACTED] (b)(6) current machine. The data on this hard drive had been copied from it to [REDACTED] (b)(6) new machine as part of the life-cycle swap when it occurred.

Without specific guidance to search for and the manual process of searching through every file or email on gigabytes of data, there is nothing on any of the machines that I found that I would have considered pornographic. There are several instances within [REDACTED] (b)(6) and [REDACTED] (b)(6) data that is adult themed and inappropriate for the government workplace. There are even a few emails from [REDACTED] (b)(6) which imply an unfriendly or hostile work environment. However, I found nothing to substantiate [REDACTED] from violating AR 25-2 by removing machines from the network without prior consent or her not asking for assistance on a possible issue of pornography. I also must question why [REDACTED] would have a government hard drive at her home and why the mounting brackets are facing the wrong way.

AR 25-2 states:

(7) Release, disclose, transfer, possess, or alter information without the consent of the data owner, the original classification authority (OCA) as defined by AR 380-5, the individual's supervisory chain of command, Freedom of Information Act (FOIA) official, Public Affairs Office, or disclosure officer's approval.

(5) As a matter of normal auditing, SAs/NAs may review web sites logs, files downloaded, ingress and egress services and similar audited or related information exchanged over connected systems. Supervisors and managers may receive reports detailing the usage of these and other internal information systems, and are responsible for determining that such usage is both reasonable and authorized.

(7) SA/NAs may provide assistance to Army supervisory and management personnel, under lawful authority, to examine archived electronic mail, personal computer file directories, hard disk drive files, and other information stored on ISs. This information may include personal data. Such examinations are typically performed to assure compliance with internal policies; support the performance of administrative investigations; and assist in the management and security of data and ISs.

(8) When IA personnel discover information during the course of their normal activity that indicates a violation of acceptable use or a possible criminal offense, they will immediately report the finding to their Commander. The commander will immediately report known or suspected criminal activity to LE and will consult with legal counsel concerning activities that appear merely to violate acceptable use. IA personnel will retain and provide information related to the matter to LE when required.

(9) With the exceptions of the SA/NA as identified below, Army personnel and contractors are prohibited from browsing or accessing other user's e-mail accounts.

(10) The SA/NA may only intercept, retrieve, or otherwise recover an e-mail message and any attachments thereto, only under the following circumstances:

(a) With consent (expressed or implied) of a party to the communication involved.

(b) In response to a request for technical assistance from:

1. LE/CI personnel pursuant to a properly authorized LE/CI investigation.

2. A supervisor as part of a non-investigatory management search in accordance with paragraph 4-5t, below.

3. An investigating officer pursuant to a properly authorized administrative investigation (for example, a preliminary inquiry under Rule for Courts-Martial 303, an informal investigation under AR 15-6, or a preliminary inquiry under AR 380-5).

4. Information systems security monitoring personnel pursuant to properly authorized IS security monitoring activities.

5. Inspector General personnel pursuant to an authorized inspection, investigation, or inquiry.

(11) The SA/NA may remove any e-mail, file, or attachment that is interfering with the operation of an IS without consent of the originator or recipient. The SA/NA will notify the originator and recipient of such actions.

(12) The SA/NA is not authorized to use techniques or software to penetrate or bypass user's information protections (for example, content restrictions or read-only protections

used to maintain or enforce document integrity, version control, or need-to-know enforcement).

t. Management search. In the absence of the user (for example, TDY, extended hospital stay, incapacitation, emergency operational requirement), only the SA/NA is authorized limited access to the user's files to support administrative management searches to provide the requested information as required for official purposes. When such access is requested, the SA will-

- (1) Brief the supervisor as to the limits of accessing the user's data files.
- (2) Limit the scope of the authorized search to those files reasonably related to the objective of the search (that is, email access would not be reasonable when searching for a word document file).
- (3) Limit the search to the time necessary to locate the required data in the most relevant file location.
- (4) Inform the individual of requested file access as soon as possible after such requests, and document this access in a memorandum.
- (5) SAs/NAs will not grant unrestricted supervisory access to individual information, data files, or accounts.
- (6) SA/NAs will not access individual information or data files unless conducting a management search, an authorized administrative search, or supporting a LE/CI authorized investigation.
- (7) SA/NAs may conduct an authorized investigative or management search of assigned IS upon an individual's termination of employment, death, or other permanent departure from the organization to retrieve data and files associated with the organizational mission.

9. I, (b)(6), WANT TO MAKE THE FOLLOWING STATEMENT UNDER OATH:

On 27 May 08 at 1100 hours, I attended a meeting with (b)(6) (Executive Director, ATSC), (b)(6), and (b)(6) I attended this meeting at the request of (b)(6) since I was serving as the Acting Director of ITSD at that time.

The purpose of this meeting, as I recall, was for (b)(6) to establish and document the facts associated with (b)(6) discovery of alleged pornography and other improper material on one of her employees (b)(6) PC.

During the meeting (b)(6) indicated that based on his looking at material from a packet that (b)(6) had provided (b)(6) (ATSC Deputy) he had notified his supervisor (Mr. Seger) of an email string that in his view inaccurately suggested an inappropriate relationship between (b)(6)

During this meeting (b)(6) questioned (b)(6) regarding the circumstances of her becoming aware of potential pornography and other improper material on (b)(6) PCs. She indicated that an ATSC SA initially brought it to her attention. She reviewed the files on the hard drive and printed out several examples that illustrated improper use of Government equipment, distribution of pornography, solicitation of sex, and lack of respect for chain of command on (b)(6) part. (b)(6) questioned (b)(6) what actions she took with regard to securing (b)(6) PC and (b)(6) indicated she took the hard drive home and secured (b)(6) PC in a cabinet in her office.

(b)(6) also asked (b)(6) what her intent was with including in this packet an email string between him and (b)(6) regarding an upcoming office Christmas party and I believe a surprise birthday party for (b)(6) wanted to know whether (b)(6) would be able to attend. (b)(6) indicated that the tone of (b)(6) email showed disrespect to (b)(6) position and also indicated an improper use of the chain of command for inviting the Executive Director to an office party (b)(6) felt that including this email in this packet insinuated an improper relationship between (b)(6) (b)(6) stated that was not her intent. (b)(6) further indicated that he often received invitations to attend these type of office functions by personnel in ATSC. He also provided (b)(6) the context in which the email between he and (b)(6) occurred. He indicated that while (b)(6) was emailing him regarding the party he was in a car with (b)(6) coming back from a TDY and that (b)(6) was on the telephone with (b)(6) at the same time they were exchanging emails.

At some point during the meeting (b)(6) pulled out the Civilian Table of Punishment and Penalties. He discussed with Sheila if she was aware of the penalties for making false statements about a supervisor.

The nature of the meeting often felt more like an interrogation than a meeting to ascertain the facts surrounding this situation. It made be feel uncomfortable and unsettled.

(b)(6) was present during a meeting held on or about 27 May 2008, beginning at 1100. Other attendees were (b)(6) and (b)(6) The ATSC Deputy Director, (b)(6) was not present.

(b)(6) initial understanding of the meeting's purpose was discussion of new facts discovered by (b)(6) in connection with ongoing investigations. However, (b)(6) focused the meeting on a theme that (b)(6) was "out to get him" based on (b)(6) including a copy of a single blackberry exchange between (b)(6) among many copies of (b)(6) possible misuse of government information systems. SUBJECT: Statement Pursuant to 4 August 2008 Office Call

1. (b)(6) moved into building 1514 on or about July 2007. The reason given for the move was because her office in building 2789 was under renovation. My understanding is that the environment in building 1514 became caustic when (b)(6) moved into the building. (b)(6) and her supervisor visited me on or about 26 October 2007. They stated they had concerns about (b)(6). I stated they should proceed with their own interventions and that I would keep an arms length in case I had to be a deciding or adjudicating official in an administrative action. Ultimately, (b)(6) supervisor forwarded an administrative action regarding (b)(6) to the Civilian Personnel Advisory Center for staffing. Both persons retired from civil service before the administrative action was completed.

2. I have knowledge of two potential Information Technology (IT) violations. The Deputy Commander, Army Training Support Center (ATSC) gave me a folder of printed materials on or about 20 May. The folder contained some questionable material. The folder was assembled by (b)(6) from material she acquired from (b)(6) hard drive.

a. I stated the hard drive needed to be scanned for pornography. If the hard drive contained child pornography, we would notify the Criminal Investigation Division (CID), otherwise, we would take administrative action.

b. I stated (b)(6) printing of the material was irregular. The proper procedure for potential IT violations was to notify the Director, Support Directorate, ATSC when the questionable material was discovered, and that we would have to consider administrative action.

3. On or about 22 May, the Support Directorate secured the hard drive and three other computers to scan for pornography. The (b)(6) ATSC contacted CID during the same time frame, with three outcomes. In paraphrase:

a. CID stated (b)(6) actions were improper when printing the questionable material, possibly warranting a hand slap.

b. CID would get involved only if child pornography was found on the hard drive or computers. No child pornography was found.

c. There was a possibility that government employees may have arranged a tryst at government expense. If the Temporary Duty (TDY) was for valid mission, CID would not get involved.

SUBJECT: Statement Pursuant to 4 August 2008 Office Call

4. I briefed my chain of command on or about 23 May and received two taskers on 3 June:

a. "Admin action appropriate for ATSC employee(s) wrt pornography on a govt computer."

I gave this action to the Deputy Commander, ATSC after the Support Directorate provided the scan results on 3 July. The Deputy Commander determined a hand slap for [REDACTED] was not needed. Other administrative action appropriate for an ATSC employee with pornography on a government computer, (b)(6) is under consideration by the Deputy Commander.

b. "Recommend you discuss with dLD Acting Director to determine G3/5/7 DLD employee was on a legitimate TDY mission to determine where we go from here on that allegation. Let me know results of legitimacy of TDY question."

I provided the following results, with concurrence from the dLD Acting Director on 30 June:

I reviewed the Government TDY records for the ATSC employee from December 2002 through February 2007. I provided the TDY dates to the dLD Acting Director. The dLD Director reviewed the TDY records for the dLD employee from 2003 through 2007. We compared the travel records for each employee and found no TDY correlation. There was no instance of the two employees on TDY for the same dates. Since there was no instance of the two employees on TDY for the same dates, I conclude the two employees did not use government funds for personal reasons.

1. Pursuant to your 4 August 2008 appointment, [REDACTED] completed an AR 15-6 investigation into allegations that federal and contractor employees at HQ TRADOC, G-3/5/7, and U.S. Army Training Support Center, Fort Eustis, used government equipment and/or resources to transmit inappropriate email messages and photos to other employees, and as to some employees, improperly shared passwords and accessed other users' email accounts, all in violation of AR 25-1 and AR 25-2. You are the approval authority for this investigation.

2. The investigation is legally sufficient. I recommend that you approve the investigating officer's findings and take action upon his recommendations by signing Section VIII of the enclosed DA Form 1574.

3. Background of Investigation. This investigation was directed by the U.S. Office of Special Counsel (OSC), pursuant to a whistleblower complaint.

a. In May 2008, while in the process of searching and downloading relevant Video Tele-Training and Satellite Education Network files, [REDACTED] (a supervisor at the Army Training Support Center) discovered pornographic and other inappropriate images and PowerPoint presentations within email folders on the hard drive from [REDACTED] (federal employee) former computer. [REDACTED] had emailed some of these images and presentations to Soldiers, federal employees, and federal contractors. [REDACTED] consolidated her findings and provided them to [REDACTED] (Deputy Director of Army Training Support Center), who delivered them to the Acting Executive Director, [REDACTED].

b. On 27 May 2008, [REDACTED] hosted a meeting with [REDACTED], [REDACTED], and [REDACTED]. Rather than address the discovered images and the organization's appropriate response, [REDACTED] focused the discussion on other items. [REDACTED] focused on a single email thread between [REDACTED] and himself. [REDACTED] additionally focused on [REDACTED] method of discovery. Lastly, [REDACTED] read [REDACTED] the civilian table of punishment and penalties, directing the statements at [REDACTED]. The meeting never discussed [REDACTED]'s images and email files. Unknown to [REDACTED] at this time, [REDACTED] directed [REDACTED] to continue the investigation of [REDACTED] AR 25-1 and 25-2 violations.

c. [REDACTED] then had her husband, [REDACTED] (also a federal employee) use [REDACTED] door policy seeking to bring this matter to the attention of [REDACTED]. [REDACTED] represented his wife's complaint to [REDACTED] ([REDACTED]'s Assistant Deputy). [REDACTED] Brashear obtained legal counsel from [REDACTED] of this office. On that counsel, [REDACTED]

c. ATSC leaders receive appropriate professional training designed to enhance their ability to effectively lead their organization and to appropriately respond to Equal Employment Opportunity issues.


